3. A monthly complimentary value aggregated to RM5,000.00 will be allocated for the Programme throughout the Programme Period, which shall be given on a "first come, first served" basis while stocks last.
4. To participate in the Programme and be eligible for the Complimentary Value, the following requirements must be fulfilled -
